

Ramsey County Elections 2009 Election Calendar

This calendar contains selected dates for the 2009 election process. Please consult the Minnesota election law for complete details. Unless otherwise provided, “town” means White Bear Township and “city” means the cities of Maplewood, White Bear Lake, New Brighton, Falcon Heights, Lauderdale, and St Paul. Unless otherwise provided “school district” means ISD 282 (St Anthony), ISD 621 (Mounds View), ISD 623 (Roseville), ISD 624 (White Bear Lake), and ISD 625 (St Paul).

Dec 30	First day to file affidavits of candidacy for town offices
Jan 13	Last day to file affidavits of candidacy for town offices (5:00pm)
Jan 15	Last day to affidavits of withdrawal for town offices (5:00pm)
Feb 2	Year-end campaign financial reports due
Feb 6	Begin absentee voting for town election
Feb 17	End of pre-registration of voters for town election (5:00pm)
Feb 27	Pre-election campaign financial reports are due for annual town election
Mar 7	Extended hours for absentee voting for town election: 10:00am – 12:00pm
Mar 9	Extended hours for absentee voting for town election: 8:00am – 5:00pm
Mar 10	Town general election
Mar 17	Last day to file certification of filing for campaign finance reports for annual town election
Apr 9	Post-general election campaign financial reports due for town election (211A.02, subd 1)
Jul 7	First day to file affidavits of candidacy for all school districts and for cities with a primary
Jul 21	Last day to file affidavits of candidacy for all school districts and for cities with a primary (5:00pm)
Jul 23	Last day to file affidavits of withdrawal for all school districts and for cities with a primary (5:00pm)

Jul 31	Last day to file statements of economic interest (City of St Paul only)
Aug 14	Begin absentee voting for city and school district primary
Aug 25	End of pre-registration of voters for city primary (5:00pm)
	First day to file affidavits of candidacy for city offices without municipal primaries and for school district offices
Sep 4	Pre-primary campaign financial reports due
Sept 12	Extended hours for absentee voting: 10:00am – 3:00pm
Sept 14	Extended hours for absentee voting: 8:00am – 5:00pm
Sept 15	Municipal and school district primary – polls open 7:00am – 8:00pm
Oct 2	Begin absentee voting for general election
Oct 13	End of pre-registration of voters for general election (5:00pm)
Oct 23	Pre-general election campaign financial reports due
Oct 31	Extended hours for absentee voting: 10:00am – 3:00pm
Nov 2	Extended hours for absentee voting: 8:00am – 5:00pm
Nov 3	Municipal and school district general election – polls open 7:00am to 8:00pm
Nov 10	Certification of filing for campaign financial reports due
Dec 3	Post-general election campaign financial reports due
Jan 4, 10	Terms begin for officials elected at Nov 3 general election
