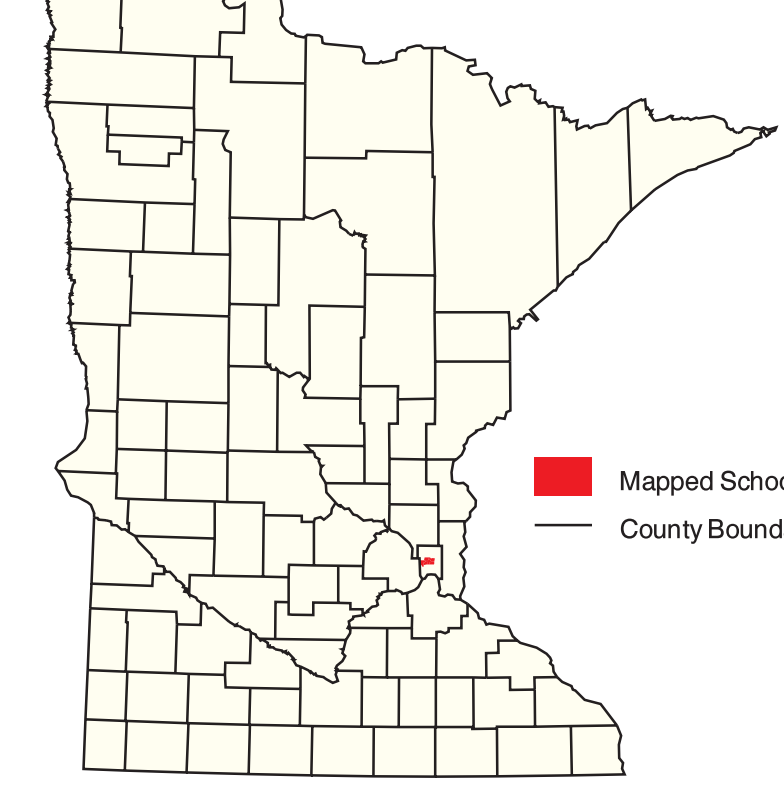

STATE OF MINNESOTA

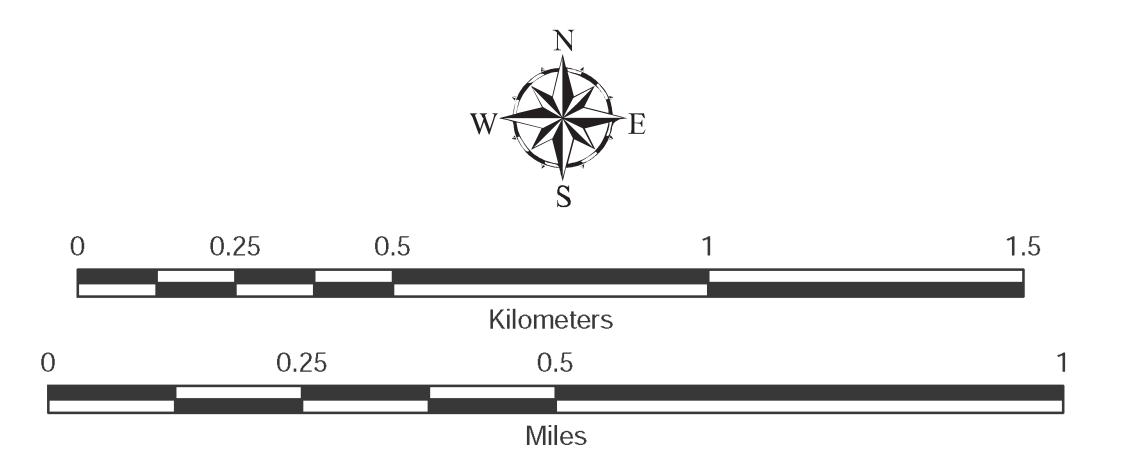
