Ramsey County Campaign Finance Board,

This letter is in regards to the attached 2006 end of year campaign finance reports for 2006. In the calendar year 2006 Progressive Minnesota PAC legally changed its name to TakeAction PAC. That name change is reflected in the "amendment" Statement of Filing attached to this letter. In addition to the name change, TakeAction PAC (fka Progressive Minnesota PAC) also changed its bank from Associated to Bremer: that is also reflected in the "amendment" Statement of Filing. Finally, TakeAction Minnesota PAC (fka Progressive Minnesota PAC) made no expenditures in Ramsey County or the City of Saint Paul towards city or county candidates or referenda. This is why the expenditure line reads 0. However, TakeAction PAC did receive \$137,500 in contributions over the course of 2006. The vast majority of these contributions then left the TakeAction PAC Bank Account as expenditures in state level races. These expenditures are reflected in the TakeAction PAC state campaign finance filing. Please contact me if you have further questions about the TakeAction PAC campaign finance filings.
