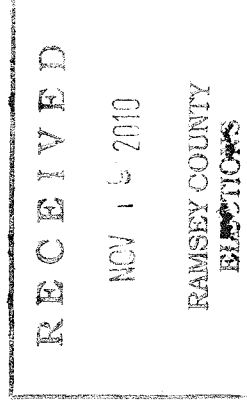
Michael Kuehn was elected Mayor for the term of 4 years.




