A political committee or political fund may make an independent expenditure provided that:</p> <ul style="list-style-type: none">▪ the communication contains a statement (disclaimer) that the activity is an independent expenditure and the candidate is not responsible for it; <i>and</i>▪ this statement (disclaimer) is included in oral communications, in conspicuous type on the front page of all literature and advertisements published or posted, and at the end of all broadcast advertisements; <i>and</i>▪ the treasurer of the committee or fund making the independent expenditure reports the expenditure on an <i>Affidavit and Report of Independent Expenditures</i> with a sworn statement that the expenditure was not made with the authorization or expressed or implied consent of, or in cooperation with or in concert with, or at the request or suggestion of any candidate, candidate's committee, or candidate's agent.
Loans Payable	Loans that the committee or fund owes to a financial institution, individual, or other entity.
Loans Receivable	Loans that are owed to the committee or fund from other individuals or entities.
Miscellaneous income	Money received by the committee or fund that is not a contribution or loan (i.e., interest from an interest bearing account).
Unpaid bills	Advance of credit for goods or services for which payment has not been made. An advance of credit is an unpaid bill from the time it is incurred, regardless of when an actual invoice is received.
