

# JEFFERSON COMMONS AT BERRY STREET

KNOW ALL MEN BY THESE PRESENTS: That Jefferson Commons - Berry, L.P., a Delaware limited partnership, owner of the following described property situated in the City of Saint Paul, County of Ramsey, State of Minnesota:

Blocks 2 and 3, "Eustis' Addition to St. Anthony Park, Ramsey Co., Minn.;"

Together with vacated Pearl Street (formerly Pym Street) lying between said Blocks 2 and 3, lying West of the West Right-of-Way line of Berry Avenue and lying East of the West line of Section 29, Township 29, Range 23;

Together with West one-half of vacated Berry Avenue lying between the Southerly line of the former Northern Pacific Railway Company right of way and a line beginning at the intersection of the East line of Berry Avenue and the Northerly line of vacated Pearl Street; thence running Northwest to the point of intersection of the West line of Berry Avenue and the Northerly line of vacated Pearl Street and there terminating;

Together with those parts of Pearl Street, originally dedicated as Pym Street and Berry Avenue, as dedicated in "Eustis' Addition to St. Anthony Park, Ramsey County, Minnesota", according to the recorded plat thereof, Ramsey County, Minnesota, which lie northerly of the southeasterly extension of the southwesterly line of Lot 7, Block 3, said "Eustis' Addition to St. Anthony Park, Ramsey County, Minnesota", which lie easterly of the westerly right-of-way line of said Berry Avenue, which lie westerly of a line and its southerly extension drawn 33.00 feet easterly of and parallel with the east line of Block 2, said "Eustis' Addition to St. Anthony Park, Ramsey County, Minnesota" and which lie southerly of a line drawn from the point of intersection of the east line of said Berry Avenue with the northerly line of said Pearl Street to the point of intersection of the west line of said Berry Avenue with the northerly line of said Pearl Street.

Further together with the northeasterly 33.00 feet of that part of Vacated Territorial Road, Saint Paul, described as follows:

Beginning at a point on the West line of Section 29, Township 29 North, Range 23 West, said point being the Southwesterly corner of Lot 12, Block 3, "Eustis' Addition to St. Anthony Park, Ramsey Co., Minn.;" thence Easterly along the Southerly line of said Block 3, 311.08 feet more or less, to its intersection with the Northerly extension of the Westerly Right-of-Way line of Berry Street; thence Southerly along said extension 69.33 feet, more or less, to its intersection with the Southerly Right-of-Way line of vacated Territorial Road; thence Westerly along said Southerly Right-of-Way line of vacated Territorial Road, 310.99 feet, more or less, to the West line of said Section 29; thence Northerly along said West line 69.27 feet to the point of beginning.

Has caused the same to be surveyed and platted as JEFFERSON COMMONS AT BERRY STREET and do hereby dedicate the easements as shown on this plat for drainage and utility purposes.

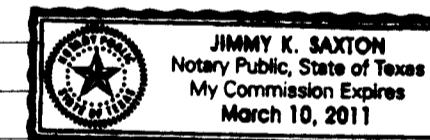
