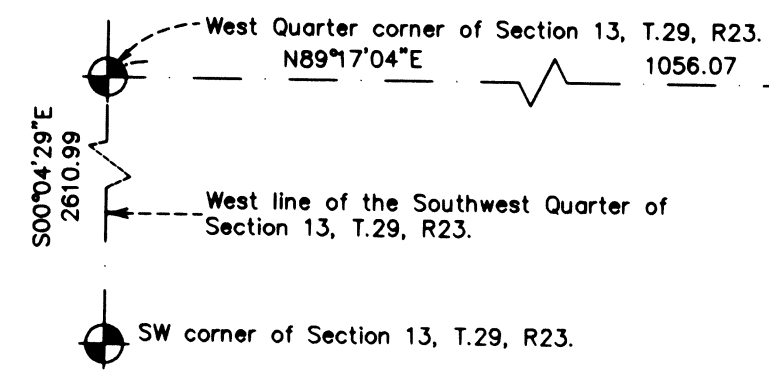


# MOORE'S McCARRON'S PRESERVE

Lots 14, 15, 16, 17, 18, 19, 20 and 21, Block 4, ROLLING GREEN, Ramsey County, Minnesota;

and

That part of CHANDLER AVENUE and McCARRON BOULEVARD as dedicated on the plat of ROLLING GREEN, Ramsey County, Minnesota, which lies northerly of the westerly extension of the south line of Lot 14, Block 4, said ROLLING GREEN, and lies southerly of the following described line:

The northerly line of Lot 15, Block 4, said ROLLING GREEN, extended westerly to the intersection with a line 30 feet east, as measured at right angles, of the west line of said ROLLING GREEN; thence continuing westerly on a tangential line to the west line of said ROLLING GREEN and said line there terminating.

Has caused the same to be surveyed and platted as MOORE'S McCARRON'S PRESERVE and does hereby dedicate or donate to the public for public use forever the public way and drainage and utility easements as shown on this plat.

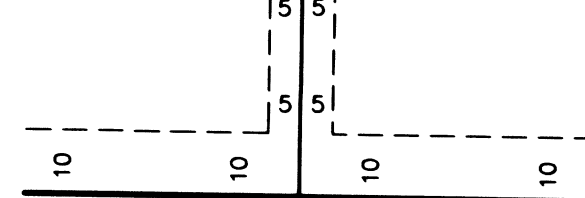

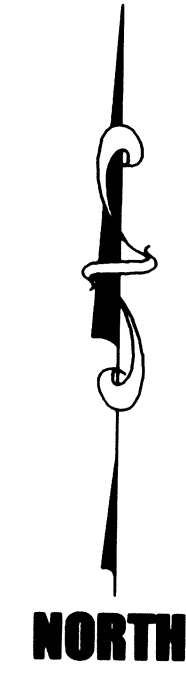
